Mayor Clark McLane called the meeting to order at 6:00 p.m., and Mr. Kyle opened it with prayer. All the members were present. Judge Robert Jackson, Public Works Director Bob Gary, Light and Power Superintendent Lee Wellman, Solid Waste Director Lee Brumley, Inspector Jeremy Chesnutt, Library Director Lindsey Cox, Chief Garrett Foster, and Fire Marshall Brandon Duckworth gave departmental reports. There was one public comment. Wretha Rawls spoke about placing a flag at Byrd Park, Bingo, and the Fireworks Show.

Council Member Angel McCroskey made a motion to approve the minutes from the regular council meeting on November 10, 2025. Council Member DeMarcus Holmes seconded the motion. The motion passed unanimously.

Council Member Lequin Hilderbrand made a motion to approve no fishing in the pond the week of January 19-23 for the Trout Derby. Council Member DeMarcus Holmes seconded the motion. The motion passed unanimously.

Laura Carrera with URBANO Architects presented a report of the Beaty Orton House findings and recommendations.

Council Member DeMarcus Holmes made a motion to table indefinitely the Kendig Keast contract amendment for the zoning ordinance project, changing the timeframe in section 5.2. Council Member Angel McCroskey seconded the motion. Much discussion was made. Council Members Mamie Horn, DeMarcus Holmes, and Angel McCroskey voted in favor of the motion. Council Members Bob Mayhar and Lequin Hilderbrand voted against the motion. The motion passed 3-2.

Council Member DeMarcus Holmes made a motion to approve the redesignation of the basketball pavilion at Sandy Creek Park to a general-purpose venue. Council Member Bob Mayhar seconded the motion. Much discussion was made regarding the fee and other things that should be considered before the item is voted on. Council Member DeMarcus Holmes amended the motion to table the item. Council Member Angel McCroskey seconded the motion. Council Members Mamie Horn, DeMarcus Holmes, Angel McCroskey, and Lequin Hilderbrand voted in favor of the motion. Council Member Bob Mayhar voted against the motion. The motion passed 4-1.

During the council time discussion, Mayor McLane commended the city on a job well done at Christmas in the Park. Council Member Bob Mayhar invited citizens to the annual Trout Derby at the pond on January 24, 2025. Council Member Mamie Horn thanked everyone for the help with the Turkey Drive. Council Member
