The Regular Called City Council Meeting was called to order by Mayor Randy Sayers at 6:00 p.m., all City Council Members were present to wit with the exception of Council Member Anderson Land who was not well and Rashad Lewis who was working.

Mayor Sayers asked for questions or comments on departmental reports. None were made.
Mayor Sayers asked for Public Comments. None were made.

Motion by Council Member David Shultz to approve the following minutes:
Regular Called City Council Meeting, June 13, 2022 and Special Called City Council Meeting, June 21, 2022. Second by Council Member DeMarcus Holmes. Motion carried unanimously.

Motion by Council Member David Shultz to approve the City's Second Quarter Investment Report.
Second by Council Member Michael Daniel. Motion carried unanimously.

Motion by Council Member David Shultz to approve Ordinance No. 07-11-22 Re-Adoption of the Juvenile Curfew Ordinance. Second by Council Member DeMarcus Holmes. Motion carried unanimously.

Motion by Council Member David Shultz for the school to provide their own or to help cover more of the expenses related to hiring the additional officers. Second by Council Member Michael Daniel. Council Member DeMarcus Holmes abstained from voting. Motion died due to lack of quorum.
Mayor Sayers suggested taking this back to the school board and we could hold a Special Called Meeting if needed.

Motion by Council Member David Shultz to approve Invoice No. 2244 Gulf Coast Strategic Highway Coalition Annual Membership Dues \$1,250.00. Second by Council Member Michael Daniel. Motion carried unanimously.

Motion by Council Member David Shultz to approve the 5-year EMS Contract with Allegiance Mobile Health pending the City Attorney's review and approval. Second by Council Member DeMarcus Holmes. Motion carried unanimously. (NOTE – Approval was received from Michael Ratcliff on July 12, 2022).

CLOSED EXECUTIVE SESSION: Mayor Sayers stated he and the Council will enter into Closed Executive Session at 6:20 p.m., Pursuant to Texas Government Code 551 Section 551.072 Deliberations about Real Property, discuss options regarding the old DETCOG building.



Mr. Rodney Norsworthy gave the opening prayer.


